WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
WHAT?	The types of personal information we collect and share depend on the product of service you have with us. This information can include: Social security number Personal Data: Residents, Phone Numbers, Personal References, and Assets Employer/ Military Unit, Job Title, Rank or Pay Grade, Supervisor, and phone numbers Source of Income, Credit Information, Bankruptcy, Judgments, Suits, and Repossessions
HOW?	All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Jones Finance, Inc. chooses to share; and whether you can limit this sharing.

Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes – information about your creditworthiness • affiliates from using your information to market you • sharing for nonaffiliates to market you State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	We are limited by the applicant authorization.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and non financial companies: None
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Plateau Insurance Group: United Motor Club Credex Systems, Inc.: Citizens Union Bank Payments Gateway: Army Aviation Center Federal Credit Union
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. None
